I did some re- evaluating of the outpatient surgeon's services for surgery and went back and looked into the index for mastectomy, including axillary lymph nodes. I first seen the code 19302, so I turned to page 111, and seen that it wasn't what I was looking for. Then I kept looking at the other codes following it and seen code 19307-Mastectomy, modified radical, including axillary lymph nodes with or without pectoralis minor muscle, but excluding pectoralis major muscle. Then my next step was to find the services ordered. I realized they didn't have a preoperative package, and everything had to be ordered separately. First, I looked up ECG (tracing only) in the index and it gave me code 93005, so I went to page 757 and the code stated ECG tracing only without interpretation and report. Then I started to look up the blood work. I looked up the cbc with platelet and differential panel, and in the index, it gave me the code 85025, so I went to page 664 and found that it was exactly what I was looking for. Then I looked up the comprehensive metabolic panel in the index, and it gave me code 80053, and I went to page 596 and I found it was the right code. Then I went to the index and I found the code for Covid screening (amplified Probe Technique) 87635, and I found that on page 682. Then I looked in
